In the following years, more serious attention began to be paid to the issues of developing national spirituality, ensuring spiritual security, raising the spiritual image of members of society. All this is evidenced by the fact that the process of forming a new spiritual space in our society has become trending. In particular, in the following years, a sharp decrease in the desire of state authorities to influence market realities, to "coordinate" economic processes in a circular way, caused the evolutionary finding of the mechanisms of a literal market economy. Such an economy requires members of society to immediately adapt to changes in the labor market, to master new professions and trades that are in demand in this market.
